The Board of County Commissioners, Casey Lair, & Jerry Scott, Kayla Busch, County Clerk, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room. Commissioner Miller was absent.

The satellite office in Neodesha is having lighting issues that she hopes to have resolved next week. She also reported that one of the new vaccine freezers has stopped working but is still under warranty and should repaired next week.
