OFFICIAL MINUTES**

December 31, 2025

The Board of County Commissioners, Casey Lair, Andrew Miller & Jerry Scott, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room. County Clerk Kayla Busch was absent.

**CALL TO ORDER:** Commissioner Lair called the meeting to order.

**INVOCATION:** Commissioner Miller gave the invocation.

**PLEDGE OF ALLEGIANCE:** Commissioner Scott led the flag salute.

**AGENDA & MINUTES:**

**ACTION:** A motion was made by Commissioner Scott to approve the agenda as presented, and approve the minutes of December 17, 2025 as presented. Commissioner Miller seconded the motion, and the motion carried.

**COORDINATOR'S REPORT:**

Kris Marple, County Coordinator, presented Resolution #2025-015 authorizing the transfer of \$10,000.00 from the Election Fund to the County Equipment Reserve Fund, Resolution #2025-016 authorizing the transfer of \$50,000.00 from the Sheriff General Fund to the Special County Reserve Fund, Resolution #2025-017 authorizing the transfer of \$300,000.00 from the Road & Bridge Fund to the Special Machinery & Equipment Fund, Resolution #2025-018 authorizing the transfer of \$300,000.00 from the Road & Bridge Fund to the Special Highway Improvement Fund, Resolution #2025-019 authorizing the transfer of \$5,000.00 from the County Treasurer Special Auto Fund to the County Treasurer Special Auto Reserve Fund, Resolution #2025-020 authorizing the transfer of \$14,912.64 from the County General Fund to the BC/BS Pathways Fund & fund closure, and Resolution #2025-021 authorizing the transfer of \$36,766.44 from the County General Fund to the COVID-19/ELC/IAP Fund & fund closure. He also submitted the 2026 Solid Waste Disposal Agreements with the Cities of Fredonia & Neodesha. He also presented the Emergency Solutions Grant Agreement with the Kansas Housing Resources Corporation in the amount of \$16,432.00. He also submitted a property tax abatement request from Rossinda Murphy per KSA 79-1613 due to her residence destroyed by fire.

**ACTION:** A motion was made by Commissioner Miller to adopt the year-end fund transfers Resolution #2025-015 through #2025-021 as presented. Commissioner Scott seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Miller to approve the 2026 City Solid Waste Disposal Agreements as presented. Commissioner Scott seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Scott to approve the ESG Agreement as presented. Commissioner Miller seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Miller to approve pursuant to KSA 79-1613 the property tax abatement request for Rossinda Murphy as presented. Commissioner Scott seconded the motion, and the motion carried.

1. Approved warrants in the amount of \$260,050.83 & payroll in the amount of \$124,868.93.
