CALL TO ORDER: Commissioner Lair called the meeting to order.

Kris Marple, County Coordinator, presented a quote from Advantage Computer in the amount of \$1,977.00 for a new computer in the County Attorney's Office. He also discussed having a health fair by Wilson Medical Center for employees covered by the health insurance plan, which was approved by consensus.

FY2022 COUNTY HEALTH & DENTAL INSURANCE PLAN RENEWAL:

Dick Osterbuhr, Insurance Broker, presented the employee health & dental insurance plan renewal for 2022. Aetna health insurance premiums will increase 4.5%, and no increase in premiums with Delta Dental.

ACTION: A motion was made by Commissioner Miller to approve the employee health & dental insurance plan renewals for 2022 as presented. Commissioner Scott seconded the motion, and the motion carried.
