**CALL TO ORDER:** Commissioner Lair called the meeting to order.

**ROAD & BRIDGE DEPT. REPORT:**

Kay Tatum, Road & Bridge Supervisor, and Kevin Starbuck discussed pending bridge repair estimates for 250 & Franklin Road in the amount of \$20,000.00 and 2300 & Decatur Road in the amount of \$70,000.00, which were approved by consensus. Kary also discussed asphalt road repair plans for this summer. He also reported ditch work on 1250 Road between Decatur & Edwards Roads, and on Decatur between 1050 & 1100 Roads. He also reported that the surplus property sold on Purple Wave in the amount of \$31,900.00. He also presented a right-of-way permit for Wylie Blann.
