EMPLOYEE HEALTH INSURANCE RENEWAL FOR 2021:

Dick Osterbuhr, Insurance Broker, presented the 2021 health insurance renewal from Aetna for eligible County employees. The premium rate increase will be 5%, but with a return of premium for November making the effective rate a 0.8% increase. He also reported that there will be no increase in premium for Delta Dental. Also, eligible employees will continue to get \$800 per year in Flexible Spending Accounts.

ACTION: A motion was made by Commissioner Miller to approve the renewal with Aetna for County health insurance for 2021 as presented. Commissioner Scott seconded the motion, and the motion carried.

COUNTY COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented the CDBG-CV applications for Round #2 approval. He also submitted a Neighborhood Revitalization Plan application for Steve Jantz.

ACTION: A motion was made by Commissioner Scott to approve the CDBG-CV applications for Round #2 as presented. Commissioner Miller seconded the motion, and the motion carried.
