

**WILSON COUNTY, KANSAS
OFFICIAL MINUTES**

June 18, 2025

The Board of County Commissioners, Casey Lair, Andrew Miller & Jerry Scott, Kayla Busch, County Clerk, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Scott led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as presented, and approve the minutes of June 11, 2025 as presented. Commissioner Miller seconded the motion, and the motion carried.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, reported that the recent real estate tax foreclosure sale grossed \$84,750.00. The Commission consented that they would not change the designated holiday.

HEALTH DEPT. REPORT:

Amy Lell, Health Dept. Administrator, reported that there are currently four counties in SW Kansas with active measles cases. She also informed that there were WIC funding cuts of 8% equivalent to \$44,000.00.
