

**WILSON COUNTY, KANSAS
OFFICIAL MINUTES**

March 4, 2026

The Board of County Commissioners, Casey Lair, Andrew Miller & Jerry Scott, Kayla Busch, County Clerk, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Scott led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as presented, and approve the minutes of February 25, 2026 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE DEPT. REPORT:

Kary Tatum, Road & Bridge Supervisor, discussed equipment repairs, and assisting with a culvert bridge on Mill Street in New Albany.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented Neighborhood Revitalization Plan applications for Hayden Newton and Janet Maxwell. He also submitted the County Emergency Operations Plan Promulgation for the revisions submitted & approved by the Kansas Department of Emergency Management. He also presented a letter of support for the Wilson Medical Center grant application to USDA Rural Development for funding an ambulance facility. He also discussed an upcoming surplus property silent auction at the Courthouse, which was approved by consensus. He also submitted March employee birthday cards, and gave a Legislative Update pertaining to pending legislation affecting Counties.

ACTION: A motion was made by Commissioner Scott to approve the County EOP Promulgation as presented. Commissioner Miller seconded the motion, and the motion carried.

ACTION: A motion was made by Commissioner Lair to approve the letter of support for the WMC USDA Rural Development grant application. Commissioner Scott seconded the motion, and the motion carried.

2. Approved by consensus to cancel the County Commission meeting on March 18th.
3. Approved warrants in the amount of \$326,454.19, and payroll in the amount of \$131,549.12.
