**ACTION:** A motion was made by Commissioner Richardson to approve the agenda as presented, and approve the minutes of November 6, 2017 as presented. Commissioner Miller seconded the motion, and the motion carried.

**ROAD & BRIDGE DEPT. REPORT:**

Kary Tatum, Road & Bridge Supervisor, reported that the striping on Harper Road & 300 Road has been completed, and was \$800 less than quoted. He also discussed a request for trees to be cleared from the right-of-way at 1300 & Wichita Road.

**HEALTH DEPT. REPORT:**

Destany Wheeler, Interim Health Dept. Administrator, reported that flu vaccinations were continuing to be given. She also informed that the new vaccination freezer has arrived. She also presented the 2018 WIC grant contract with KDHE in the amount of \$119,342.00. She also reminded that she will be attending the Four Corners Preparedness Conference this week in Branson, MO. The Commission also discussed increasing her pay rate for the interim administrator period.

**ACTION:** A motion was made by Commissioner Miller to accept the WIC grant contract for 2018 as presented. Commissioner Richardson seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Miller to increase Destany Wheeler's pay rate from \$15.18 to \$16.83 per hour effective retroactively to July 31<sup>st</sup>. Commissioner Richardson seconded the motion, and the motion carried.

**COORDINATOR'S REPORT:**
