CALL TO ORDER: Commissioner Lair called the meeting to order.

MINUTES:

ROAD & BRIDGE DEPT. REPORT:

He also submitted a pay increase request for Johnathan Robinson due to completing his introductory period.

ACTION: A motion was made by Commissioner Miller to approve Resolutions #2017-020, 2017-021, 2017-022, 2017-023 & 2017-024 as presented. Commissioner Richardson seconded the motion, and the motion carried.

ACTION: A motion was made by Commissioner Miller to approve a \$0.50 per hour pay increase for Johnathan Robinson. Commissioner Richardson seconded the motion, and the motion carried.
